I hereby acknowledge and represent that the individual named in section one of this document is an employee of this agency and that his/her participation in the Connecticut SWAT Challenge arises out of, and in the course of his/her employment by this agency.

To the fullest extent permitted by law, this agency hereby agrees to indemnify, defend and hold harmless the Indemnified Parties identified in section one of this document together with their respective employees, officers, officials, volunteers, agents and representatives from any and all liability, claims, demands, damages, expenses, fees, fines, penalties, suits, proceedings, actions, and cost of actions, including attorney's fees for trial and appeal, arising from or connected in any way with this individual's participation in or attendance at the Connecticut SWAT Challenge. The agency agrees this provision includes, but is not limited to any claims based on negligence, action, or inaction by any of the Indemnified Parties, employees, officers, officials, volunteers, agents and/or representatives and further includes but is not limited to claims pursuant to Connecticut General Statutes §31-293 and/or §31-293a or their successor provisions.

Additionally, this agency agrees to maintain insurance coverage throughout the duration of the Connecticut SWAT Challenge. It's agreed that the scope and limits of the insurance specified are minimum requirements and shall not limit or exclude the Indemnified Parties from additional limits or coverage provided under each policy. Said policies shall be primary and non-contributory and include a Waiver of Subrogation in favor of the Indemnified Parties. All required policies (with the exception of Workers' Compensation) shall name the Indemnified Parties as an additional insured. The agency shall provide a certificate of insurance signed by a person authorized by the insurer prior to the event in compliance with the required coverage types and amounts:

1) <u>Commercial General Liability</u>:

\$5,000,000 combined single limit per occurrence for bodily injury, personal injury, property damage, contractual liability and products /completed operations. Policy shall be endorsed to include Law Enforcement Liability.

2) <u>Automobile Liability and Physical Damage Coverage</u>:

\$1,000,000 combined single limit per occurrence for any auto, including statutory uninsured/underinsured motorist coverage and \$1,000 medical payments. Policy shall include collision and comprehensive coverage.

3) Workers' Compensation:

<u>Coverage A / Workers' Compensation</u>: statutory limits as required by the Labor Code of the State of Connecticut. <u>Coverage B / Employer's Liability</u>: limits of \$100,000 each accident, \$500,000 disease/policy limit, \$100,000 disease/each employee.

4) <u>Personal Property</u>:

The agency agrees to assume all risk of property damage or loss to personal property of the agency and its employees from whatever cause which may arise from the participation in or attendance at the Connecticut SWAT Challenge.
